We herewith offer you contractual engagement to carry out the above mentioned assignment specified in the Attached Terms of Reference (Annex-I).

1. Consequent upon your selection made by the selection board, you are hereby offered to carry out the assignment of **Supervision Consultant-Civil at Jaipur-TA** on a contract basis for a period of 12 months on a consolidated fee of Rs 25,000/- per month (Rs. Twenty Five Thousand only).

3. Other conditions of your service under the project will be governed by such rules as may be adopted by the Society from time to time.
4. Please note that your offer is also subject to:
 - (a) Production of a certificate of fitness from the Competent Medical Authority viz. Civil Surgeon, District Medical Officer, Medical Officer or equivalent status in the prescribed form enclosed (Annex-III)
 - (b) Production of original certificates: -
 - (c) Photo Proof of identity- (eg driving license/election card/passport etc)
 - (d) Academic certificate-12th / Graduation / Degree / Doctorate etc
 - (e) Certificate of age.
 - (f) Character certificate in the prescribed form (Annex-IV) from your present/last employer.
 - (g) Domicile certificate./Address proof
5. If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material/information, you will be

liable to be removed from the said post under the project and for such other action as the project may deem necessary.

6. On acceptance or otherwise of the terms and conditions as mentioned above, you are requested to report for duty along with the required documents latest by 16 March, 2009 to **Executive Engineer, Division-II, RHSDP, Jaipur.**
7. If you fail to join your duties by the above stipulated date, the offer of contractual engagement to you is liable to be treated as cancelled forthwith.


